 - 2016 grads can apply for 50% reduction of CVMA fees if a CVMA member in 2017
 - 2017 grads will automatically be invoiced a 75% reduction (\$76.75 plus gst) of CVMA fees
- educational members (residents and interns) and life practicing members pay 50% of CVMA fees
- CVMA membership due reductions if eligible are available for maternity/parental and illness disability leave – you must apply directly to the CVMA
- CVMA fees are optional for life non-practising, sabbatical and social members
- applicants applying for active membership after June 30 pay one-half the SVMA fees for the respective category; this does not apply to sabbatical, social memberships (educational membership is excluded effective May 3, 2018)
- educational membership is excluded paying licensing seminar/exam fee – a separate licensing seminar will be held for WCVM interns/residents/graduate students
- all fees are subject to GST
- accounts more than 30 days overdue will be charged 2% per month, compounded monthly, from the date of the invoice
